This was a legacy S+C grant and while housing costs were covered, the grantee and subgrantee determined that they were unable to administer the project with additional support services funding. They will work to secure new PSH for the participants in the final year of the grant. The conversation that they were not going to renew the grant began in early 2024. They did not submit a renewal application, which was due on 08/13/24. And an email was sent to them confirming that the grant would not be included due to their decision on 10/09/24.

After reviewing the project application and a three year historical project spend-down, which averaged spending less than 40% of the grant, with no anomalies, the Rank & Review Committee made the recommendation and the Governing Council approved the reduction. The agency was notified, by email, on 10/08/24, ahead of public project listing notification.
